To enable the student to recognise and understand the legal aspects of doing business in the context of international trade.

COURSE DESCRIPTION:

This course provides the student with basic knowledge of that part of Canadian law which will be encountered in international trade situations, including the workings of the Canadian legal system; the law of tort, bailment, contract, agency, incorporated companies, carriage of goods by sea, marine insurance, bills of lading and letters of credit; the law relating to choice of forum (where to sue) and choice of governing law (which law applies); and the law relating to fluctuations in exchange rates and interest rates. Much of the subject-matter of the course will be illustrated in the later seminars by the facts of an in-depth case study.
